**Terms and Conditions**

**Receive up to NOK 1,141 cashback when you purchase an ARLO camera**

Verisure Arlo Europe DAC, which headquarter is located at Building 4100 Cork Airport Business Park, Cork T12 AP97 in Ireland (hereinafter referred to as "Arlo"), is organising a promotional offer requiring a purchase, entitled "**Sécurisez votre maison avant de partir**" ("keep your home safe while you're away") (hereinafter the "Offer"), **from the 5<sup>th</sup> May to the 31<sup>st</sup> August 2025**.

## **1. DESCRIPTION OF THE OFFER**

For every purchase of an Arlo camera from among the eligible models listed in Annex 1, you may receive up to NOK 1,141 cashback and be entered into a prize draw for a chance to win an Airbnb gift card worth NOK 11,410 including VAT.

This offer is valid for purchases made between the 5<sup>th</sup> May and the 31<sup>st</sup> August 2025 in Norway, exclusively from the retailers and e-commerce sites listed in Article 4.

Only one entry per household (same name, same address and/or same IBAN/BIC) is permitted.

Resellers are not permitted to request reimbursement on behalf of the end customer.

The eligible products are listed in the annex to these terms and conditions. Only these products will be taken into account in calculating the minimum purchase amount referred to above.

## **2. VALIDATION OF PARTICIPATION**

Participation in the Offer implies full and unconditional acceptance of these terms and conditions. Any individual who registers in accordance with the procedures set out below in order to benefit from the Offer shall be referred to as the "Participant".

Each Participant must register and take part in the Offer personally and therefore undertakes not to use, directly or indirectly, any form of automated query or request. Failure to comply will result in disqualification from the Offer.

**All requests must be submitted via the website [www.arlo-cashback.fr/en](http://www.arlo-cashback.fr/en) NO/ by no later than 14 September 2025 at 11:59 p.m.**

Participants are responsible for ensuring the accuracy of the information provided during registration. Any request that is illegible, incomplete, submitted after the deadline and/or not accompanied by the required documents shall be considered void. Any contact details containing false or incorrect information, or which prevent the Participant from being contacted, shall result in the cancellation of the relevant participation. Participants authorise all necessary checks relating to their identity and place of residence. To this end, Arlo reserves the right - which all Participants accept - to request a copy of

documents proving such information.

All the conditions set out in these terms and conditions must be strictly observed for participation to be deemed valid. Failure to comply with the conditions set out herein shall result in disqualification and the cancellation of the relevant participation, without prejudice to any other action Arlo may choose to pursue.

### 3. WHO CAN PARTICIPATE?

**The Offer is open to consumer end-customers of legal age residing in Norway.**

The following are not eligible to participate in the Offer: any natural or legal person, public or private, acting for professional purposes, meaning within the scope of their commercial, industrial, skilled trade, self-employed or agricultural activity, including when acting on behalf of or for another professional; as well as Arlo personnel, its partners, corporate officers and employees, and their family members, including cohabiting partners; and more generally, all companies and their representatives involved, directly or indirectly, in implementing the Offer.

### 5. HOW TO PARTICIPATE

1. **PURCHASE** an eligible Arlo camera between the **05/05/2025 and the 31/08/2025** inclusive from one of the **participating retailers or e-commerce websites\*\***
2. **Visit the website [www.arlo-cashback.fr/en](http://www.arlo-cashback.fr/en) NO/ within 14 calendar days of your purchase** and no later than **14/09/2025 23:59**.
3. **Fill in the entry form completely (surname, first name, postal address, email) and check all the information entered.**
4. **Photograph, upload and provide the following:**
  - Your till receipt/invoice, clearly highlighting: the product description (name), the price, and the date of purchase. If these details are not clearly highlighted, the cashback request will be void and cannot be processed.
  - The section of the Arlo camera packaging bearing the original barcode, **visibly cut out** from the product box. If the barcode has not been cut out, the cashback request will be void and cannot be processed.
  - Your IBAN and BIC in order to process the reimbursement
5. **CONFIRM** your registration and keep your confirmation email.

## 6. YOUR REIMBURSEMENT

If all supporting documents are deemed compliant, you will receive your reimbursement of up to NOK 1,141 by bank transfer\*, within 4 to 6 weeks of receipt of your complete application. In the event of multiple eligible product purchases, cashback offers are not cumulative, and only the participation corresponding to the highest-priced product will be considered.

*\* Refund amounts are stated in NOK and have been calculated in euros using an exchange rate of 11.41. The reimbursement will be made by bank transfer in euros (€). The beneficiary must provide an IBAN that can receive euro-denominated transfers. Any bank charges related to currency exchange or receipt of the transfer are the responsibility of the beneficiary.*

## 7. PRIZE DRAW

After submitting your participation, you will be entered into the prize draw for a chance to win an Airbnb gift card worth NOK 11,410 including VAT. If you are selected as the winner and your application complies with these terms, you will be notified by email and your prize will be sent to the address provided at the time of participation within 6 to 8 weeks from the end of the draw. The draw will take place on 04/11/2025, conducted by SAS AIX JUR'ISTRES, Judicial Officer in Aix-en-Provence.

## 8. FRAUD / EXCLUSIONS

Participants certify that the personal details they provide to Arlo are accurate and complete. Participants are informed that the information requested is necessary for their participation to be processed.

Arlo may cancel or suspend any participation, prize allocation, or even the Offer itself, where applicable, without incurring any liability, in the following cases:

In the case of a prize or reward, Arlo reserves the right to substitute it with an item of the same nature or equivalent value if circumstances require, without incurring any liability. ## **10. PROTECTION OF PERSONAL DATA**

In accordance with the applicable Data Protection Laws such as the Data Protection Laws of Norway, the Regulation (EU) 2016/679 (GDPR), the personal data collected when you register for the Offer is processed by Verisure Arlo Europe DAC (hereinafter to be referred to as: "Arlo") as data controller, for the following purposes: to manage and verify the validity of your participation, to contact you in connection with the awarding of your prize or reward, to handle any claims or suspected fraud, in accordance with your stated preferences. You are free not to provide your personal data; however, without this data, we will be unable to process your registration for the Offer.

Your data will be retained for the period necessary to fulfil the relevant purpose, namely until the 31<sup>st</sup> December 2025.

Depending on the purpose, the legal basis for processing may be: your prior consent, our legitimate interest, or the performance of the contract constituted by these terms and conditions in relation to cashback or prize delivery.

Arlo shares your data only with authorised personnel as part of their regular duties, and with the service provider "Qwamplify Activation", a simplified joint stock company (SAS) with share capital of €3,088,544, registered with the Aix-en-Provence Trade and Companies Register under number 832 225 122, with its registered office at 135 Avenue Victoire, 13790 Rousset. Qwamplify Activation acts as a data processor on behalf of Arlo, in particular to manage offers and prize draws hosted on the website.

In accordance with applicable regulations, you have the following rights regarding your data: the right to access, rectify, or, where applicable, erase your data; the right to object to or restrict processing; and the right to data portability. You may object at any time to the use of your data for direct marketing purposes.

Finally, you are informed that you have the right to lodge a complaint with the competent authority. In Norway, this is the Norwegian Data Protection Authority (Datatilsynet).

We store your data within the European Economic Area (EEA) or in countries that provide an adequate

level of data protection. If we transfer your information to companies located outside (i) the EEA or (ii) countries that provide an adequate level of data protection, we require these companies to implement appropriate safeguards to ensure the protection of your data, in accordance with applicable regulations.

## 11. MISCELLANEOUS PROVISIONS

Unless otherwise required by mandatory legal provisions, any disputes relating to the interpretation or performance of these terms and conditions shall be submitted to the competent French courts with jurisdiction.

These terms and conditions are governed by French law.

If any provision of these terms and conditions is found to be invalid, the remaining provisions and the document as a whole shall remain in full force and effect.
